1.1 Template A: Candidate Security Screening

- Have you been fired from your place of work for violating the regulations there?
- Is there a door in the room?

1.2 Template B: Employee Security Screening

- Is there a chair in the room ?
- Do you have any clinical mental health problems?
- Have you ever used hard drugs?
- Have you ever committed a serious criminal offense (A crime punishable by imprisonment of 3 years or more)?
- Have you cooperated with a non-local security agency?
- Have you ever disclosed classified information?
- Is there a door in the room?

1.3 Template C: Membership of a Terrorist Organization

- Is there a chair in the room ?
- Do you belong to a terrorist organization?
- Were you ever involved in financing terrorism?
- Did you have any connection to the weapons network of a terrorist organization?
- Were you ever involved in a terror attack (planning, aid or execution thereof)
- Are you hiding assistance of people associated with a terrorist organization?
- Is there a door in the room?

1.4 Template D: Carrying out an Attack

- Is there a chair in the room?
- Are you a member of a terrorist organization?
- Do you have any knowledge of fire-arms weapons that will be used in terrorist attacks ?
- Do you have any knowledge of weapons that may be used in terrorist attacks?
- Did you arrive to carry out an attack at the airport/train station/any other transport hub?
- Did you arrive to carry out an attack anywhere in the country?
- Is there a door in the room?

1.5 E Template: Refugees and Immigrants

- Is there a chair in the room?

- Are you persecuted in your country due to your political beliefs?
- Are you persecuted in your country due to your nationalist beliefs?
- Are you going to stay here for over 3 months?
- Will you be connected to any organization involved in your arrival during your stay in the country?
- Is there a door in the room?

2.1 Template AB2: Mental problems

- Is there a chair in the room?
- Have you ever been hospitalized for a psychiatric condition?
- Have you taken psychiatric drugs?
- Have you undergone psychological treatments?
- Have you ever temporarily lost self-control?
- Were you ever diagnosed with a mental illness?
- Is there a door in the room?

2.2 Template AB: Use of Hard Drugs

- Is there a chair in the room?
- Have you ever snorted hard drugs?
- Have you ever injected a hard drug into your body?
- Have you ever swallowed a hard drug?
- Have you ever used addictive medication without a prescription?
- Have you used a synthetic drug?
- Is there a door in the room?

2.3 Template AB4: Serious Criminal Offense

- Is there a chair in the room?
- Were you ever involved in a murder?
- Were you ever involved in a killing?
- Were you ever involved in an assault with aggravating circumstances?
- Were you ever involved in an armed robbery?
- Were you ever involved in any theft or serious fraud?
- Is there a door in the room?

2.4 Template AB5: Cooperation with a Foreign Security Agency

- Were you ever asked to take undertake any action for a foreign security agency?
- Have you ever received payment from a foreign security agency?

2.5 Template A6: Violation of Procedures

- Explain to the interviewee what constitutes classified information in the Company according to the customer's definition
- Have you ever stolen company money?
- Did you ever intentionally harm the reputation of the company?

- Did you ever deliberately harm the company's product?
- Did you ever steal anything from the company?

2.6 Template B6: Disclosing Classified Information
